## NWP and Salvation Army Ribbon Cutting April 19, 2012

In November 2011 NWP members voted to gift Salvation Army of Southern Nevada \$325,000 to rehabilitate its dilapidated emergency overnight shelter for the homeless at its Owens Avenue Campus. The grant gave the 12,500 square-foot building a new roof and new bathrooms and showers along with space for more beds. Construction started in January 2012 and was completed by April 2012. SA now has the ability to provide an additional 7,300 unique bed nights per year.

## The Grant Screening Committee Selects NWP's 2012 Grant Finalists: Goodwill Industries of Southern Nevada and Helping Hands of Vegas Valley

After four months of research, Nevada Women's Philanthropy Grant Screening Committee narrowed 2012's record number of 43 applicants for this year's \$300,000 grant down to two finalists: Goodwill Industries of Southern Nevada and Helping Hands of Vegas Valley.

Goodwill Industries of Southern Nevada seeks to fund the "Nevada Women's Philanthropy Veterans Employment Program", which will provide job retraining and job placement assistance to local veterans. Funds will cover expenses such as staff salaries and job training programs.

Helping Hands of Vegas Valley proposes to use the money to enhance its low income senior food and necessities program. The funds from the grant would be used to purchase large items such as a delivery truck, commercial grade refrigerators, freezers and industrial shelving. It would also seek to lease additional warehouse space.

The two organizations will have the next four months to create presentations for NWP's Grant Hearing on Oct. 2, 2012, where NWP's membership at large can learn more about each agency and how they intend to spend this year's \$300,000 grant. The runner up will receive a \$30,000 NWP Founder's Gift. This year's alternate is Best Buddies Nevada.

## Legal Aid Center of Southern Nevada Thanks NWP for 2009 Grant for \$325,000

*Twelve years ago, the Children's Attorneys Project at Legal Aid Center of Southern Nevada began, determined to be a voice for each child in foster care. We quickly learned that the system was flawed and weighted against these young victims. Children were languishing in foster care — some ready for adoption with loving foster families, but still unable to extricate themselves from the system. Some with behavioral problems were being overmedicated and locked away. Siblings were being separated from each other for arbitrary reasons rather than making every effort to keep them in each other's lives. And where families could be reunited, opportunities were being missed.*

*With only half of the children being represented, we asked Nevada Women's Philanthropy to assist — to allow us to represent hundreds more children and to do so differently — at the very earliest stages of the proceedings — when children are first taken from their parents. We asked NWP to help us transform our system from a lethargic, bureaucratic adversarial process to a results-oriented approach that serves children from the first day they enter the system.*

*With NWP's funding, we have helped hundreds of children from day one of their removal from their parents. Many children have been safely returned home; others found a new forever family. NWP's reputation and support gave valuable impetus to the child welfare reform movement. And NWP helped us sharpen our focus through their rigorous evaluation process. If we had to sum it up succinctly for those who are involved: you saved lives and strengthened us as we try to serve even more in need. We feel we not only gained grant funds to help vulnerable children, we feel that we gained a friend and a partner.*

## Staton Elementary School Rewarded

In 2008 the Public Education Foundation received the NWP grant of \$450,000 for three Empowerment Schools. The grant funded in 2009 with each school receiving \$50,000 per year for three years. They are: Staton Elementary, Wendell Williams Elementary, and Chaparral High School.

In the spring of 2011, Chaparral was designated a "turnaround school." All members received numerous updates on this development. Because turnaround schools are under an increased level of supervision from state officials, we felt that it was no longer considered a school that operated under the Empowerment model. As such, we decided to delay the disbursement of our remaining funds to that school to see what had transpired. As a result, NWP has a \$95,000 balance in the account of the Empowerment Schools.

In the meantime, Superintendent Dwight Jones announced that CCSD would establish "autonomous zones" based on the principles of the Empowerment Schools. Only those schools that achieved "gold" or "5-star" status under the School Performance Framework, would be given the autonomy that had previously been provided to Empowerment Schools. Staton Elementary School, led by Marty Gardner, qualifies for the "Autonomy Zone," as it achieved a 5-star rating.

After much deliberation, the Executive Committee of NWP and among CCSD administrative officials, we decided to award \$50,000 to Staton to recognize the excellence with which it has implemented the Empowerment model and to further the achievements that the school has made. The remaining \$45,000 will be used to fund "Professional Learning for the Autonomous Community." This money will provide training for principals of "autonomy schools" in the following areas: Policy/Governance, Shared Leadership, Budget and Performance Management/Supervision. Marty Gardner and her staff will play a leadership role in conducting these trainings.

## Dr. Robert Lang visits with NWP

Dr. Robert Lang, the director of University of Nevada Las Vegas's Brooking Mountain West, spoke to a group of about



50 NWP members and guests gathered at Lovee Arum's home at this spring's "State of the State" event. He revealed the findings of the think tank's recent report entitled: "Unify,

Regionalize, and Diversify." Southern Nevada's continued economic success will hinge upon building upon the visitor business, according to Lang. "Our past, present and future is all about strong visitorship," he said. "Our leaders must continue to make it easy for people to come here for business conventions, recreation and special events."

The report strongly recommends completing the \$480 million interstate roadway between Phoenix and Las Vegas and advocates a new, state of the art stadium in Las Vegas "preferably near the resort corridor."

Lang also emphasized the important role that Southern Nevada plays in the gaming arena throughout the world. No one knows the gaming business like the people who run Las Vegas casinos and our leaders should capitalize on that experience and expertise especially now as online gaming becomes a reality, according to Lang. He also emphasized how much impact the Southern Nevada economy specifically makes to the entire state. Lang urged NWP members to be aware of where state taxes are spent and suggested members exercise our political voices, know our legislators and demand that Southern Nevada receives proper funding and service allocations.
